

Picture Show Terms & Conditions for Wedding Films

Thank you for considering Picture Show for your Wedding Film. Please ensure you read this document carefully as it provides valuable information and protection for both parties. Payment of your booking deposit constitutes acceptance of these terms and conditions.

These terms and conditions constitute a contract between Picture Show and The CUSTOMER which The CUSTOMER is deemed to agree and accept fully their intention to employ Picture Show's services. It is agreed that the following terms, as they stand at the time at which The CUSTOMER indicates their desire to employ Picture Show's service, constitute a contract between Picture Show and The CUSTOMER. No variation or modification of this contract shall be effective unless agreed by both parties in writing.

This agreement contains the entire understanding between Picture Show and the CUSTOMER. It supersedes all prior and simultaneous agreements between the parties. The only way to add or change this agreement is to do so in writing.

DEPOSIT

A non-refundable \$200+GST deposit is payable to Picture Show before any wedding date can be confirmed.

The deposit is non-refundable or transferable. In the event of cancellation, the deposit is used to offset time invested by Picture Show and potential loss of other bookings. The deposit paid will be deducted from the cost of the CUSTOMER'S chosen package when calculating the final balance due.

SETTLEMENT

Payment of your wedding package must be settled with a \$200+GST non-refundable deposit to secure booking + remainder, in full, 7 days prior to wedding. We are unable to film your wedding if payment has not been made in full prior to the wedding day.

CANCELLATIONS AND POSTPONEMENTS

If you need to cancel the use of our services more than three months before your wedding date, you will be reimbursed any money paid to us, minus your \$200 non-refundable deposit. You will also be charged, at cost, if we have booked travel and accommodation to attend your wedding.

A cancellation within three months will incur a \$500 cancellation in addition to the deposit paid, plus you will also be charged, at cost, if we have booked travel and accommodation to attend your wedding.

Should your wedding date be postponed, we will do our best to meet your new dates without additional cost to you.

TRAVEL

Travel costs to your wedding and reception within Cambridge, Hamilton, Te Awamutu and Matamata are included within your chosen package. Additional charges will apply and be quoted for when outside of these locations.

CONTENT DELIVERY

A first edit of your film(s) will be delivered digitally within four to six weeks of your wedding day depending on the chosen package. Our aim is for this to be delivered sooner and we will always aim to do so.

The file will be uploaded to Google Drive and you can review it and give feedback at your leisure. Once we have received your feedback, we'll make the requested changes and send your final film(s) to you on a branded USB drive in a presentation box. If you require additional changes after the first round of feedback these can be made by Picture Show at a cost of \$100 + GST per hour for editing with a minimum 1 hour charge.

CONTENT OWNERSHIP AND USAGE

Your films are owned by you when they are fully paid for and you are welcome to use however you wish, the final exported versions. Picture Show own the raw footage and images we captured on your wedding day. Unless explicitly agreed upon in writing prior to your wedding day, Picture Show retains the right to use and share — in part or in full — all or any video footage and photography we captured from your wedding day.

We will ensure that your films are always represented in a positive, complimentary fashion and only use them for promoting our business on social media and via our website at pictureshow.co.nz

Please ensure your guests are happy to be filmed is you foresee any issues here.

FORCE MAJEURE OR ACT OF GOD

The validity of this contract is subject to alteration or cancellation by either party owing to any cause beyond their control. Although all equipment is checked regularly and all reasonable steps are taken to ensure backup equipment is available, Picture Show will not be held responsible for any video which is not produced due to technical failure. We are also not liable for any delays or inability to attend your wedding for reasons beyond our control, including thing like extreme weather events, flight delays or cancellations, vehicle breakdowns, or rental vehicle cancellations etc.

LIMITATION OF LIABILITY

In any circumstance the liability of one party to the other shall be limited to the total value of the contract. Neither party shall be liable for indirect or consequential loss, or any damage to equipment or property incurred while fulfilling this contract.

PERSONAL INJURY

Although the instance of injury is extremely unlikely any directions issued to clients, their guests, or employees during a shoot are deemed to be at said person's own risk. We cannot be held responsible for any personal accidents during a shoot.

GOVERNING LAW

This agreement shall be governed in accordance with the laws of New Zealand.
